### • Standard Revision

A note was sent to membership about participating on a committee to revise the UKC Chinook standard. Eleven members responded that they supported a revision and would be willing to participate. The committee includes long time members as well as some

newer breeders, and hopeful breeders. The first meeting was held on August 14 to discuss an approach and timeline for the work. The group agreed to the following:

### ➤ Objective/Scope:

To update the current COA Chinook standard based on input from members and judges to more clearly articulate the ideal Chinook while respecting the broader view of Chinook "type" that has sustained the breed.

### NOT in Scope:

- Complete revision of the standard
- Alignment with other Chinook standards
- Inclusion of non-Chinook type from potential new crosses

#### > Principles/Ways of Working:

- All committee members to check email and keep up with discussions
- Any difficult decisions must be decided by a 3/4 vote of committee members.

### > Revision Process:

The committee agreed that the next step should be soliciting and reviewing feedback. Key inputs to the revision process should be:

- Feedback from COA members on what they would like to see changed
- Judge feedback from the last five Specialties on what they would like to see clarified
- Feedback from experts such as canine biomechanical researchers, with the expectation the group would align on any specific feedback requests before third parties are asked to participate

### Timeline:

Requests for member and judge feedback to be sent around August 19. Three weeks will be allowed for feedback.

The President requested a vote to formally establish the committee. \*See Unfinished Business
