# President - Ed Bigos (MA)

This has been a busy year for the Chinook Owner's Association. A significant improvement to membership services has been implemented by the Membership Committee; Kris Holleran (Chair), Dave Schiller, and Chester Holleran (Information Coordinator/Website manager). Chester's expert programming has created a website with the capability for members to keep their own information up to date. Utilizing the new membership management website software the Membership Committee diligently pursued leads on Chinook owners to increase the number of active members for 2011 over the 2010 levels. This year the Working Dog Program (WDP) has become a reality. I see the program's goal to focus on the Chinook's working heritage as a great way to motivate more Chinook owners and dogs to activities that will improve the breed. Thank you to Working Dog Program Chair Corine Lindhorst, Kim Kramer, and 2010 committee members Karen Hinchy and Karen Schiller for their work to make this program a success. #### Membership - Kris Holleran (NH), Chair

Three spreadsheets were justified and merged to give an accurate accounting of membership. This information was used to create an online database of all current members. The membership renewal campaign rolled out in January of 2011. Membership in the COA currently stands as follows:

- COA now has 175 active memberships
- 22 Active Breeder Listings
- 8 paid stud listings
- 12 lifetime memberships

Records from years prior to 2009 were obtained and demonstrate a decrease of about 150 members since 2007. A database of lost members was posted for Board members to use in reaching out to friends, acquaintances and prior puppy owners. This effort contributed to a small increase in membership. Memberships are valid for the calendar year (Jan. 1 - Dec. 31) and include voting privileges for officer elections and association business, a subscription to the Chinook Quarterly newsletter, and an individual login account for this website's member area - where members may list information about themselves and their dogs. New memberships are pro-rated for the first year according to the number of full months remaining. Two-year memberships are discounted \$5. Optional services are not discounted or pro-rated. Memberships not renewed by the following March 31 will be terminated. A flat fee of \$2 is added to each transaction to partially offset PayPal charges.

Basic Memberships:

- Single: One named member (over the age of 18), one vote (\$25 1 year, \$45 2 years), pro-rated for year 1.
- **Family:** Two named members (over the age of 18), two votes. Dependents under age 18 are automatically designated as Junior Members without voting rights. (\$35 1 year, \$65 2 years), pro-rated for year 1. Optional Additional Services (require basic membership):
- **Stud Listing:** Members may opt to advertise their dogs for stud service on this website. (\$10 1 year, \$20 2 years)
- **Breeder Listing:** Members may advertise their breeding kennels and planned litters on this website. Payment of the breeder's fee *includes* the right to advertise studs. (\$50 1 year, \$100 2 years)

#### Registrar - Penthea Burns (ME)

During the last year 2 graduates from the COA CrossBreeding Program were UKC registered through the Single Dog Registration process. GreatMountain Madison and GreatMountain Macwahoc received 'PR' pedigrees. Currently the Registrar is working with the MMI, UKC and the COA Executive Board to complete the single registration for Tullibardine Mahalia Jackson. The Registrar has worked with the COA CrossBreeding Committee and the Executive Committee to approve the application of Bowerbank Jake to be included in the COA CrossBreeding Program. The UKC is no longer provided breed registry spreadsheets to breed clubs.

### Rescue – This position is currently vacant

The COA Rescue Committee assisted with a re-home of seven Chinooks from Manitoba to a number of new homes in the US. The committee is currently reviewing the lessons learned from the re-home. In addition, the committee is working to establish standard operating procedures to make future activities more efficient. Joyce Maley, Rick Skoglund and Kathleen Daniels are the current committee members. Mike Parks resigned as the Rescue Chair in April 2011.

# Health Committee - Donna Russell (NH), Chair

The Health Committee has re-established the practice of publishing quarterly reports from OFA and CERF, to the Chinook Quarterly. We have begun to have a "Health Flash" article published in the Chinook Quarterly and posted on the COA website, as well. We have established relations with the CCA Health Committee in order to gain more involvement of Chinooks and Chinook owners in current research and health studies. We began looking at the prospect of another Chinook Health Survey, but do not have a data analysis and results from a past survey completed yet. We have been in contact with Albert Jergens, DVM, MS, PhD from Iowa State University who has agreed to include the Chinook in his research on the treatment of Inflammatory Bowel Disease. He has submitted a preliminary application to obtain funding for this research.

# **CO** – This position is currently vacant

Since the last Specialty, the Chinook Quarterly has met its publication deadlines, offering members a lasting source of information on breedings, health certifications, Chinook titles and accomplishments and a wide variety of stories about COA members and their dogs. The CQ publishes the approved minutes of COA Board meetings, so members are able to keep up with what their elected representatives are working on, as well as a treasurer's report in each issue. The COA is currently seeking a new editor for the remainder of the election term (summer 2012). The elected CQ Editor notified the Board in February that the March issue would be her last, due to many other obligations in life outside the COA. A new editor was appointed, but resigned soon after. The former editor stepped in to complete the spring 2011 edition.

The Sledding, Skijoring, Packing, and Titled Events sections have all been revised. These sections are now on the COA website. Our goal is to get the Carting, Weight Pull, and Temperament Group sections finished, approved by the Board. #### Chinooks New England! (CNE!) - Ruth Lind (ME), Representative to COA Board

Chinooks New England has moved their website to www.chinooksnewengland.org.

Chinooks New England has had a busy year since the last Specialty. As usual, the club organized the Chinook Olympics at It's a Dog's World in York, Maine, an event where the whole family comes together for lighthearted competition, great food and lots of laughter. At Chinook Winter Carnival, CNE's annual winter event, dozens of 'Nooks and their families gathered at the Remick Farm Museum in Tamworth, New Hampshire for a weekend of sledding, skijoring and fellowship. CNE's annual membership meeting was held during Winter Carnival, and this year CNE members voted to cut dues by half, to \$10 for a single membership, \$15 per family. As a result, we signed up eleven new members on the spot. On the heels of Winter Carnival, CNE members represented the breed and dogsledding at the Owls Head Transportation Museum Annual Winter Transportation Festival. Chinooks demonstrated dogsledding, while CNE members coordinated display of Chinook history. The same day, Chinooks and CNE members greeted the public at the Massabesic Audubon Society in Auburn, New Hampshire, again offering demonstrations and rides. CNE is looking forward to this year's Chinook Olympics on July 16, again at It's a Dog's World. Rebecca Clapp resigned as CNE representative to the COA Board and Ruth Lind was later appointed.

#### **COA Website – Chester Holleran**

The on-line membership database has been designed to handle automatic renewals with prompts to update personal and pet information. Personal login pages show the type of membership and when the current term expires. Members are able to use a PayPal option for renewal, or may download application and renewal forms to use via USPS. The COA website has information and tips on renewal. Puppy memberships are not automated and continue to be available at half price on a pro-rated basis. The format and capabilities for this remain under construction. Until this is completed, breeders with inquiries on how to provide this service to puppy owners should contact membership services. Further updates to the COA website include Member Dog photo section, which has been very popular. The Working Dog Program information and documents have been uploaded to the COA website.
