2. Report of President –

- **3.** Report of Vice-President The Board held further discussion on procedure to be used in the revision process and how to include the membership. A template was provided to show content that the UKC would like to see in a parent club document.
- **4.** Report of Secretary The February 18, 2013 Board meeting minutes were approved by unanimous consent and have been uploaded to the COA website.

5. Report of Treasurer –

- The most recent Treasurer's Reports are posted on the Board Yahoo group in the Files Section in "Treasurer Reports" in the "2013-02 February" folder.
- Bank Accounts in progress.
 - Credit Cards –Vicky has started the initial steps of getting Karen Hinchy a credit card for the CQ.
- Current Club Activity
 - ➤ **Hurricane Fund** –The remaining Fund balance is \$1,482.18. A previously proposed motion for transfer of this balance was withdrawn.
 - ➤ Chinook Store, Calendar 114 calendars were sold. One calendar was lost in mailing, which does not justify the cost of insuring all calendar mailings.
 - ➤ **Membership Drive** –We have collected almost \$2,900 in gross membership fees in the current calendar year. PayPal appears to be running smoothly.
- **6. Report of Immediate Past President** The IPP had nothing new to report.

7. Report of CQ Editor –

- Chinook Quarterly
 - Less than 10% of the membership has opted to continue receiving paper newsletters, which will cost approximately \$200 per year in printing and mailing. A motion was proposed to move the CQ to a completely digital publication.
 - > The spring edition of the CQ is in pre-production. Board members were reminded to submit content.
- Chinook Pedigree Project Over 75% of the records that breeders have agreed to validate have been completed (670+ dogs), and all participating breeders have provided consent to make public the validated data. Over 64% (600+ dogs) of the remaining records have been validated by the group, and excellent progress is being made on wrapping up this phase. Dr. Beuchat is ready to start processing data when we have it, and the group will proceed to discussing desired outputs from the analysis.

8. Report of Bench Chair -

- We have the logo design for the 2013 Specialty. Many thanks to Chinook owner Stephanie Wheatley for sharing her artistic skills.
- We are continuing to send out details about the Specialty.
- The Board was advised of the cost to purchase a new NBOB plaque and ten "keeper" plaques. A motion was made for the approval of the purchase.
- We have blocked 25 rooms at the Microtel, Middletown. More hotel options will be forthcoming.
- All remaining items have been assigned to committee members.
- We are targeting mid-April as the send out date for the Show Premium.
- New members to the Committee include: Penthea Burns, John Habermehl, Mary Jo Crance.

9. Report of Membership Chair -

- The COA currently has 310 active memberships. Two reminders were posted on COA-L, COA
 Forum and the COA Facebook page, and an announcement was placed on the COA website. A
 spreadsheet of non-renewals was posted to the Board group so members could reach out
 personally to those who have not renewed.
- Correction to last month's report: 13 puppy memberships were received between 1/15 and 2/13/13. One new puppy membership and one new member have joined our club this month.
- Four member emails bounced when a mailing about the Specialty was sent out. Letters have been written to those members in an effort to ensure they will receive all communications from the COA.

- The Rescue Committee sent a draft proposal of the "breeder's relocation assistance program" to Kim Kramer and Ed Bigos for their comment and review.
- The Committee was involved in a rescue effort centered on dogs seized during an Animal Control raid on a sled dog touring company in Northern Michigan. The rescue effort ceased when it was determined that the dogs were not Chinooks or Chinook mixes. People interested in adopting mixes and Chinookalikes were put in touch with the shelter.
