- Membership reported the addition of five new members and five new puppy members.
- The 2014 membership renewal campaign is underway. As of 3/18/14, 73 of 150 renewals have been completed. Reminders have been sent via Facebook, COA-L and personal email.

10. Report of Committees

Registrar

The Registrar continues work with the CrossBreeding Committee, and is assisting with registration of four rehomed Hurricane Chinooks.

Publicity & Advertising

- The Publicity & Advertising Chair had nothing to report.
- Facebook Kristy Jolly, Social Media Coordinator
 We are nearing 500 "likes" for the COA Facebook page. The Board was advised of plans underway to help cultivate more interest in the Facebook page

Rescue

- The Board received an updated report on a Chinook who was taken into custody by Rescue and placed into foster care.
- The Committee has begun revising the rescue application, to help evaluate the level of experience an applicant may have with handling dogs with behavioral issues.
- The Committee is working on a new owner contract.
- A Rescue Facebook page has been created for updating information on rescues, fundraising and
 general education about breed specific rescue. A planned refresh on chinook.org/rescue is in the
 works as well. Kristy and Dan will discuss potential consolidation of the Rescue page with the
 COA Facebook page, and report to the Board in the April meeting.
- The Committee is planning sale of Hi Viz dog jackets as a Rescue fundraiser.

Historian

The Historian had nothing new to report.

Crossbreeding

- The UKC has been notified of the approved change in the CrossBreeding Program to move purebred eligibility to the third cross generation. The CrossBreeding Program requirements document has been revised to reflect both this change and the change agreed by the Board in August to accept OFA eye testing in addition to CERF testing. The draft document is currently circulating with the Committee for final review before posting to the COA webpage.
- The CrossBreeding Committee is drafting a Request for Information from some of the scientists involved in the Chinook Pedigree Project to review the current program scope, requirements, and objectives and develop a plan to renew it in the context of all of the most recent information on the Chinook breed. It is expected that the RFI would go out in May.

Health

The data from the 2008 Health Survey along with the mathematical analyses provided by an external consultant have been sent for scientific review. The purpose of the inquiry is to determine if the straight mathematical analysis done a couple of years ago was valid, or if incorrect methodology was used (straight math vs. modeled statistical sampling). Determination will be made on whether to seek additional review of the data or consider creating a new survey.

Working Dog Program

The WDP Committee is currently working on a Working Sled Dog application for Jeff Plantinga's Hurricane Mojo and a Novice Sled Dog application for Southwind in the Willows.

Nominating Committee - Kathleen
