Dwarfism Genetic Test Validation

The Dwarfism genetic test validation is in progress, with an affected dog and a parent confirmed ready to participate. Contact information has been sent to Genoscoper, with results expected in the next two months. If the validation is successful, this will be the first Chinook health issue for which we have a genetic test.

MyDogDNA 2015

Our 20% discount offer expires the end of September. The Health Committee will evaluate the information from the group genetic analysis, and plans to use it in discussions on the revision of the Cross Program. The Committee Chair will explore discount options for those who cannot participate at this time.

• Institute of Canine Biology

The Health Committee has received a quote from the ICB (Dr. Beuchat) to review our population analysis and give us a strong baseline to be used in guiding the CrossBreeding Program revision.
