The committee has been busy! Key activities include:

• Dwarfism Genetic Test

Both the affected dog and parent have received kits and returned samples to Genoscoper. Hopefully in the next month we will hear if the first genetic health test for the Chinook is validated.

• MyDogDNA 2015

Unofficial reports indicate over 50 kits were sold with our 20% discount. This is extremely exciting, as we needed 30+ dogs for the first reports on genetic diversity within the breed. We could be in the range of 1/3+ of our breeding population being tested, making their Breeding Tool an incredible opportunity for us.

As of 27 October, there are 17 Chinooks with public results on MDD - several other owner/breeders have indicated they have made their dog's profiles public, and are awaiting results.

• Population Analysis

In progress with ICB.

• Cross Program

The committee has agreed on the process to revise the Cross Program. Key steps include:

- > Obtain a baseline of the current Chinook population data (see above)
- Solicit input from geneticists based on the population data and our current program
- Solicit input from membership/Chinook breeders via a structured survey

- > Finalize input from Committee members
- > Synthesize all input into a new proposal

As part of the revision, the Committee has discussed rebranding the program and updating goals/objectives. The current best thinking for it includes:

PROPOSED PROGRAM NAME:

Chinook Breed Conservation Program

PROPOSED PROGRAM GOAL:

The Chinook Breed Conservation Program is a long-term program developed in partnership with the United Kennel Club, Inc. (UKC) to maintain a healthy, genetically sustainable Chinook population, with the breed's historical temperament, working ability, structure, and appearance.

PROPOSED PROGRAM OBJECTIVES:

- Develop and manage a sustainable gene pool for the Chinook
- Improve the health and longevity of Chinooks by reducing inbreeding
- Decrease average COI of litters born from 37.4% to below 15% by 2030
- Increase effective population size as measured through the CPP pedigree database from ~17 to 40 by 2030
- Identify other breeds/ breed types who can improve the temperament, working ability, structure or appearance of Chinooks to better model the historical ideal
- Educate breeders on population genetics (where/how their dogs fit)
- Provide tools to breeders to support better decision making in planning breedings both for the individual dogs and for the breed

Fundraiser

The Health Committee is planning fundraisers to help replenish COA funds spent on the population analysis. The first fundraiser is a long sleeve t-shirt/hoodie sale, using a logo designed by Corine Lindhorst. The Board extended thanks to Corine for the time spent volunteering on this project.
