- 15. Report of Committees
  - a. 501©(3): The committee (Kim Chair, Denise, and Vicky) have completed their draft of revisions to the Constitution and ByLaws. Per the current bylaws, we interpret our activities thusly:
    - i. **Section 15.1** The written recommendation for amendment shall be submitted to the Board of Directors. *The written recommendation consists of the changes suggested by the attorney.*
    - ii. **Section 15.2** The President shall appoint a Review Committee to consider all aspects of the proposed amendment. After a complete duty of the amendment, the Chairperson of the Review Committee shall file a written report to the Board of Directors. *The Review Committee was originally chaired by John H, and then was chaired by Kim. Denise and Vicky are committee members. The official report to the board will be attached to the draft. To summarize, we have adopted the recommendations from the attorney, and added further changes to the draft.*
    - iii. **Section 15.3** The issue must carry a two-thirds (2/3) vote of the entire Board of Directors before it is presented to the membership. The issue is then presented to the membership for voting as stated in Article 9.05. *The board should schedule a vote for March or April.*
    - iv. **Section 15.4** If all the foregoing criteria have been satisfied, the new amendment shall be adopted, so recorded by the Secretary and published in the official club publication. *This will be scheduled later this spring*.
    - v. A copy of the bylaws and draft will be sent to the committee as soon as possible. Kim requests that the board review the information.
  - b. Breed standard committee
    - i. The committee met via Zoom and are working through the breed standard point by point. The first meeting went very well!
- 16. Unfinished Business
  - a. Vicky: DNO insurance/rescue insurance. The board would have to get 'shelter insurance' if we took ownership of dogs released into rescue. The cost isn't prohibitive—approximately \$1000USD/year with an animal floater policy that would cover bites to humans and other dogs for approximately \$250USD/year. Cost is not the biggest concern; the designation of being a shelter would require being registered in all the states that we might be dealing with dogs.
    - i. The hybrid method of the breeder taking possession or a foster home taking possession, with the COA helping, would allow the COA to avoid the issue of being "owner" of any surrendered dog.
    - ii. Denise comment: the attorney saw little risk in taking possession of dogs. The attorney's opinion is that there is little risk that the COA would be considered a rescue or shelter if we take possession of a dog. However, if the COA gets insurance to operate as a rescue that creates a more complicated situation.

- Vicky spoke to someone at the department of agriculture, and their position was that if the COA took possession of a dog then the COA is a shelter by definition.
- iii. Question from Kristy: is general liability insurance a possibility? Liability transfer is a sticky situation and we do not necessarily want to offload the liability or risk onto a foster.
- iv. Comment from Karen: networking with other rare breed communities to see how they handle rescue situations can give us insight
- v. Comment from Kim: reaching out to local/state government or writing an editorial to discuss the difficulties of navigating rescue designation as a breed club/community is a possibility as well
